Benefits of Serving Health First Colorado Members

Health First Colorado (Colorado's Medicaid Program) covers more than 1.4 million Coloradans – this is **1 in 4 Coloradans!** As a Health First Colorado provider, you have the opportunity to improve access to care and health outcomes for this population. Colorado is at the forefront of Medicaid reform and a model for other states. With this, there are benefits as a contracted provider that you may not know about.

You will receive extra support and multiple payment opportunities:

As the Health First Colorado contractor that administers physical and behavioral health benefits for Regions 6 and 7, Colorado Community Health Alliance (CCHA) is now contracting primary care providers (PCPs). ***The Colorado Department of Health Care Policy and Financing (State) requires that all PCPs are contracted by March 30, 2018 in order to complete the attribution process for a July 1, 2018 start date.***

Value-based payment

CCHA is developing a value-based per member per month (PMPM) payment agreement that will replace the current PMPM payment. Once this agreement is completed and approved by the State, CCHA will amend contracts to include PMPM payments. To be eligible for this PMPM payment at the go-live date of July 1, PCPs must return the signed contract by March 30. If not contracted by March 30, the State will not be able to attribute members to the PCP for several months and a delay in PMPM payments will occur.

Delegation opportunity

CCHA offers a delegation program that allows PCPs to handle care coordination for their attributed members. This program is available to practices that meet all of the PCP medical home expectations from the State. Through the delegation program, CCHA will work closely with providers and the State to develop a value-based payment methodology that meets member needs and addresses overall health. More information will be available about the delegation policy in coming months.

To help you as a Health First Colorado provider, we offer:

- **Provider Relations** to educate, orient and connect PCPs to Health First Colorado and CCHA services
- **Practice Transformation Coaches** to help providers meet practice goals
- **Care Coordination services** to refer members to a team of nurses, social workers and community resource specialists who loop information back to the PCP
- **Centralized call center** to assist both providers and members
- **Behavioral health** integration to help PCPs refer members to the appropriate services and providers
- **Specialist** referral assistance
- **Incentive payment opportunities** for achieving performance targets on State-identified measures and for providing quality care and services to members

CCHA Funding Opportunities!

In 2017, CCHA offered funding opportunities including the Provider Incentive Program, conditional funding to work on performance measures and health neighborhood reinvestment dollars. CCHA plans to continue value-based funding opportunities going forward. More information will be available in July 2018.

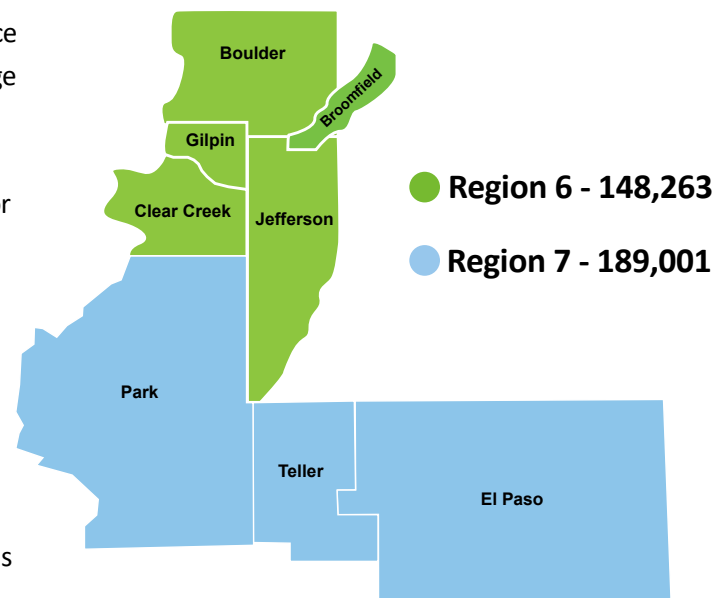
